<u>CRA Minutes of Annual Meeting</u>; <u>June 4, 2018</u>: Barbara Pusey, Secretary read the minutes from last annual meeting. Minutes were approved.

<u>Treasurer's Report</u>: Julie Knobil – "through May doing pretty well"; final day is June 30<sup>th</sup>. Treasurer's Report approved. Budget is prepared by the Finance Committee; Julie is the chair and it has been posted on bulletin board. Budget for next year: we have 100 committees and activities, 36 are not funded by CRA, but 64 committees do receive funds; 10 committees receive over 75% of our budget. Our budget for next year is \$66,000. There are 5 committees that share their proceeds with us, about \$13,000.; the committees are Woodshop, Sunflower Shop, Ceramics, Copier and Jewelry. The request for money, to support the CRA, received \$36,000., about 55% of their projected budget of \$66,000. 173 households donated, each averaging about \$200. We had hoped that a projected \$15,000 contribution from the "remainder fund" would be sufficient to fund the budget. It turns out that this estimate was too small to completely fund the 2019-2020 budget. The shortfall will be made up by an increase in the adjustment in the contribution from the remainder fund.

Detailed budget sheet was printed and available. Treasurer's Report approved.

<u>Constitution and Guidelines</u>: 5-year review; David Rhoads reported that "little was changed, just sharpened the language"; one change: the word for "**reserve fund**" was changed to "**remainder fund**". However, Sara Jane said that this is really in "Policies and Guidelines", not in the Constitution. 2019 Report was approved.

<u>Nominating Committee</u>: Elizabeth Rhoads, chairman; Peg Parker, Maggie McCaskey, Alice Stryker, Dick Baxter, Ray Firmin, Julie Knobil.

Nominations for 2019-2020: Executive Board: President, Thomas Swain; 1<sup>st</sup> Vice President, David Rhoads; 2<sup>nd</sup> Vice President, Nancy Crowe; Secretary, Valerie Suter; Treasurer, Julie Knobil; Assist. Treasurer, Ben James.

**Directors:** term ending 6/30/21: Bill Heald, John Hurt, Pat Koedding, Sandy Leff, Lowell McMullin. Director to replace David Rhoads for 2019-2020 is Marge Moretzsohn, who will join Directors: Edie Cannon, Robin Harper, Peggy Newton, Bill Wells. Since there were no others proposed, the slate was presented. Nominations were approved.
